Dear Sir/Ma'am,

This is in furtherance to our intimation dated January 31, 2026, wherein we had informed that the Office of the Assistant Commissioner of Income Tax, Central Circle 1(1), Pune (Income Tax Department) (the "**Authority**") had issued an assessment order and a corresponding notice of demand dated January 30, 2026, amounting to Rs. 31,36,30,330/- for AY 2022-23, by way of an addition of Rs. 93,57,99,520/- to the total income of Brainbees Solutions Limited ("**the Company**") for AY 2022-23.

In this connection and pursuant to Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform that based on the application made by the Company to the Authority and on verification of the case records by the said Authority, the Company is in receipt of the rectification order and demand notice from the Authority wherein the total income of the Company for AY 2022-23 is now recomputed as Rs. 52,54,110/-, thereby reducing the amount of demand for AY 2022-23 from Rs. 31,36,30,330/- to Rs. 38,37,210/- (i.e. by Rs. 30,97,93,120/-).

The Company will be filing an appeal before the Hon'ble Income Tax Appellate Tribunal (ITAT) in due course. We would like to emphasize that the Company has always maintained high standards of integrity, corporate governance, and compliance in all aspects of its operations, including the prompt payment of taxes. We remain committed to upholding these standards.
