1. During the selected quarter on September 30, 2024, a Corporate Action was affected for transfer of shares from Brainbees ESOP Trust (Trust) to employees who have exercised their employee stock options, pursuant to which 1,26,135 equity shares (as held in demat mode) got debited from Trust account (NSDL) but were credited to Employee account (CDSL) on October 01, 2024.

Due to the aforesaid reason, equity shares in demat mode in CDSL as on September 30, 2024 were less of 1,26,135 equity shares and Number of equity shares held in dematerialized form (XIV) in this shareholding pattern is reduced by 1,26,135 shares which subsequently got credited in employee CDSL demat account post quarter ended September 30, 2024.

Nonetheless, out of 519184169 fully paid up equity shares of the Company, 519184168 equity shares are held in dematerialized form.

2. Brainbees Employees Welfare Trust is categorised under the Trust category as the same is not formed under the SEBI (Share Based Employee Benefits and Sweat Equity) Regulations, 2021.
